## Our Mission

Arlington Free Clinic (AFC) advances health equity by providing comprehensive, whole-person healthcare to our neighbors who would otherwise lack access.

## Our Patients

Established in 1994, AFC continues to be Arlington's only provider of comprehensive healthcare services for adults living with a low income and without health insurance. All AFC patients live in Arlington and have incomes at or below 200% of the Federal Poverty Level (for a family of four, this is \$60,000). Every year, with the help of 300 volunteers and 45 full/part-time staff, AFC provides access to comprehensive, patient-centered services to 1,400 of our community's most vulnerable residents.

AFC's model is one in which physicians, counselors, pharmacists, dentists, and physical therapists practice side-by-side, creating a unique and integrated system of care that supports the prevention and early detection of diseases that have strong linkages across healthcare disciplines (e.g., diabetes and gum disease). Collaborative practice is highly regarded as effective and as a model, is core to how we provide care at AFC.

There are two ways to become a member of AFC and access our comprehensive healthcare services:

1. We accept approximately 25 new patients per month from a list of those who have either called or walked in seeking care.
2. Eligible individuals referred by VHC Health, Arlington County Department of Human Services, and other safety-net organizations are directly accepted. These include our sickest patients, such as those with cancer, uncontrolled diabetes, and renal failure.

AFC is one of the only organizations in Arlington providing direct healthcare services while simultaneously advancing systems-level change. Many organizations focus on either treating their patients or working upstream to change the conditions that are contributing to poor health outcomes. With our paired priorities, we better serve our patients by having a clear understanding of the systemic barriers they face in achieving good health and can bring stronger systems-level solutions to the table as members of county task forces.

**PATIENT STORY:****Luis**

"Luis" hadn't been feeling like himself. Working as a cook was hard on his body, but he had a sense that something else was going on. His wife was expecting their first child, and this had given Luis a newfound appreciation for the interconnectedness of his life and the lives of those who depend – and would soon come to depend – on him.

He shared his concerns with a co-worker who happened to be a patient at Arlington Free Clinic and soon Luis had access to comprehensive healthcare for the first time in years. After learning he had diabetes and high cholesterol, and gaining free access via AFC to the medications, education, and other resources needed to manage these conditions, he began to feel much better! But years in the kitchen had done a number on his feet. AFC called upon Edward Pozarny, DPM, a local podiatrist who generously provided two pro bono foot surgeries this year, getting Luis back to work – and to chasing after his daughter – pain free!

Luis recently registered his daughter for pre-k at Thomas Jefferson Elementary School. Reflecting on his health journey that began before she was even born, he shared how much he has come to value himself and his well-being since taking charge of his health: "if I'm good, then she and her mother are good – and so are my elderly father and my brother back home in Guatemala." AFC has a responsibility to patients like Luis who are themselves shouldering great responsibility in their families and throughout the community every day.

## The Important Role of Primary Care at AFC

Arlington Free Clinic is a truly comprehensive healthcare home where patients receive all they need to get and stay healthy, be that dental or behavioral healthcare, hearing screenings or physical therapy. At AFC, it's not uncommon for a patient being seen for a medical complaint to not only leave with a prescription, but also a referral for supplemental groceries or housing assistance – or that colonoscopy they're due for.

At the core of AFC's model is a strong and well-integrated primary care program, without which we could never sustain such a deep level of services. Patients seen by our dentists, for example, also must have been seen in primary care in the past year. This allows us to ensure that patients in our dental chairs, the majority of whom require deep cleanings (that can dislodge bacteria and be risky for those with cardiac conditions) or dental procedures (where there's a risk for bleeding in patients on blood thinners) are medically stable to receive oral healthcare.

At AFC, our primary care team – 23 volunteer providers and a staff nurse practitioner – holistically approaches each patient's healthcare in such a way that past issues (e.g., a high blood pressure reading at their last appointment) and present needs (e.g., preventive health measures such as vaccines and colonoscopies) are being routinely assessed and addressed. Staff nurses and medical assistants play a key role in our model. Their work preparing patient charts in advance of each appointment helps flag important information for the provider and maximizes our ability to deliver care that goes beyond simply addressing the need that brought the patient in.

About 12 years ago, we added a staff family nurse practitioner with the idea that through this position, we would be able to offer timely access to care for acute needs. Over time, this role has evolved to be the template for our whole primary care model and gives us the ability to pilot new practices – like oral health histories and behavioral health screenings in primary care – that have the potential to transform care delivery clinic-wide. Our nurse practitioner also follows patients with episodic issues like an uncontrolled chronic disease and manages healthcare long-term for those who have extremely low health literacy and very complex needs. Good primary care is important for everyone, but the foundational role it plays at AFC cannot be overstated.

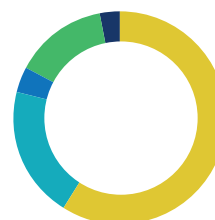

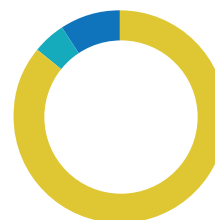

# Numbers That Count

Arlington Free Clinic is grateful for the extraordinary support of community partners, volunteers & donors. Working together, our major achievements of FY23 include:

**1,376**  
Patients Served

**1,376 patients received comprehensive, whole-person healthcare.** We added 307 Arlington residents as new patients who previously lacked access to healthcare. Of these 18% came to us by referral from VHC Health, community shelters, and other safety-net organizations.

**367**  
Volunteers

**12,062**  
Hours of Service

Volunteers are integrated into all aspects of patient care and clinic operations at AFC. Last year, 367 volunteers provided over 12,062 hours of service. The value of their volunteer hours is estimated to be \$1,141,425.

Over 100 Gala and Special Gifts Committee volunteers donated countless hours to planning and raising funds through our Annual Benefit Gala.

# AFC provided 8,214 healthcare visits for 1,376 individual patients.

AFC delivered high-quality, patient-centered care to 1,376 unique patients in 8,214 visits between July 1, 2022 to June 30, 2023.

## Awards & Highlights

### Awards

**Charity Navigator**, the nation's largest charity evaluator, once again awarded AFC its top rating of 4 stars for financial health, accountability, and transparency. AFC is proud to be recognized as a four star charity for the ninth consecutive year.

**Arlington Women's Civic Alliance (AWCA)**, an organization devoted to friendship and philanthropy in Arlington, VA and adjacent communities, selected AFC's Vision & Hearing program as the recipient of their 2023 Benefit and 30th Year Celebration. Members raised \$30K in support of our Vision & Hearing Program that provides exams, eyeglasses, and hearing aids for AFC patients. This gift follows another incredibly generous gift of \$25K in 2022 in support of our dental program. A big thank you to AWCA members for the enormous difference they have made to our work!

### Highlights

**Social Determinants of Health (SDOH)/LINK Grant:** Did you know that AFC has a Community Resource Navigator on staff whose role it is to conduct patient needs assessments and make referrals for services "beyond the exam room" including housing assistance, supplemental groceries, legal aid, transportation, county gym memberships, and more? While some of these services may not necessarily seem health-related, they play a big role in our patients' overall health and well-being.

For the past five years, AFC and three local health safety-net partners (VHC Health's Outpatient Clinic, VHC Pediatrics, and Arlington County DHS Maternal Health) have been funded by Northern Virginia Health Foundation through our LINK grant to use data to better understand non-medical patient needs and advocate to local leaders for lasting solutions to these important health determinants.

**Increased Dental Demand:** AFC served 32% more dental patients and held 38% more dental visits between January-June compared to the prior year – and our dental procedure counts were up by 125%! AFC's medical and dental teams have spent the past two years focused on integrating work across the two departments (e.g., blood pressure screenings at dental visits, medical-to-dental referrals, etc.), and the hard work is paying off: in the last six months of the fiscal year, there were 120 referrals from medical staff to dental – up from approximately 33 in all of 2021 and early 2022!

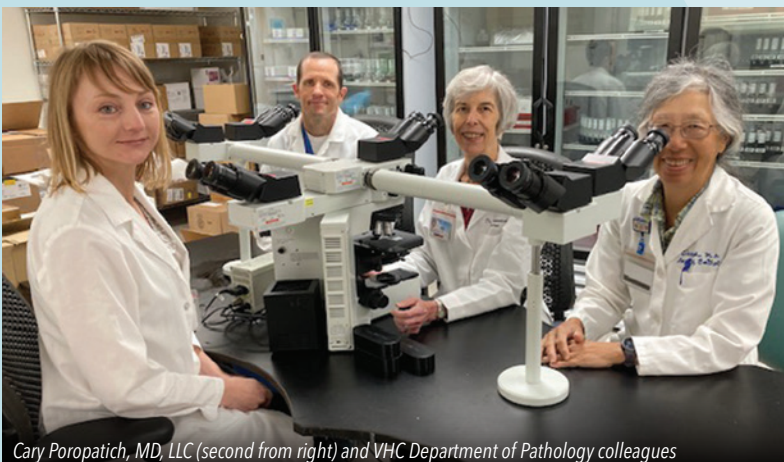
### Dr. Sara Varghai, NOVA Optique + Eyecare

Located in the heart of Ballston, Dr. Sara Varghai opened NOVA Optique + Eyecare in March 2021. A strong believer in the idea that sight shouldn't be limited to those who can afford quality eye care, giving back to her community through a pro bono partnership with Arlington Free Clinic has been part of her business model since the beginning.

For nearly two years, Dr. Varghai has generously saved one appointment slot per week for an AFC patient. Our clinical case manager uses these appointments for patients with acute eye care needs as well as for those who have complained of poor eyesight and are due for a check-up. Dr. Varghai provides a comprehensive eye exam and generously donates a free pair of glasses to every patient we refer. If a more serious problem is identified, one that may require surgery, for example, she alerts the Clinic so we can make a referral to a specialist.

Dr. Varghai shared about a rather young AFC patient who had only one seeing eye. During her appointment, Dr. Varghai stressed the importance of glasses for protective reasons and encouraged the patient to reach back out in the future should she need anything. Several months later, the patient was experiencing flashes in her good eye. Thankfully, everything was fine, but Dr. Varghai was happy she felt comfortable calling her office so she could have her mind put to ease right away.

We are tremendously grateful to Dr. Varghai and her compassionate staff for their service to the patients of AFC. So many simply need glasses to help them get through the day and wouldn't otherwise be able to access.

## VOLUNTEER SPOTLIGHT:

# The Impact of AFC's Volunteer GYN Team

Given that 65% of AFC's 1,400 patients are women, our team of volunteer women's health providers – Colleen Borelli, MD, Christine Pintz, NP, David Powers, MD, Rupali Singh, MD, and Laura Stone, MD – fulfill a critical dimension of AFC's comprehensive care by addressing general gynecological needs, providing survivorship services for those diagnosed with breast and cervical cancer, and ensuring access to potentially life-saving preventive screenings.

Coming out of the pandemic, cervical cancer screening in particular has been a great priority of AFC's women's health program, given how important early detection is to successful outcomes. While we have a wonderful partnership with the Women's Imaging Center at VHC Health that allowed us to keep pace with the need for mammograms all through COVID, screening for cervical cancer requires an appointment at the Clinic. Since most women need screening every 1-5 years, we fell behind while we were limiting onsite care during the height of the pandemic. These days, we're keeping our

volunteer gynecologists very busy and have quadrupled the number of cervical cancer screenings completed compared to last fiscal year.

Our women's health team works in partnership with the VHC Health Outpatient Clinic GYN program to provide additional testing and biopsies when an abnormality is detected during screening – and thanks to a longstanding partnership with VA Cancer Specialists, we are able to provide access to the full range of cancer treatment, should a need arise.

AFC is careful to avoid duplicating services available elsewhere in the community, so to fully meet the women's healthcare needs of our patients, we partner with Arlington County DHS where women may access prenatal care, contraception, and STI testing.

Thanks to our volunteer GYN team for being the strong foundation of this program, and for the significant impact they make on the health of the women of AFC!

# Campbell Family Foundation: Increasing Access to Complete Oral Healthcare at AFC

The Campbell Family Foundation became a founding donor to AFC’s dental program in 2015 with a gift of \$30,000 to support start-up costs associated with hiring a dentist to work part-time in borrowed space at the Arlington County DHS building. The program has evolved immensely since then, growing to a three-chair dental clinic in our own facility that provides everything from cleanings and fillings to dentures and crowns six days a week. The Campbell Family Foundation has remained a committed and consistent supporter since the beginning.

Unlike AFC’s medical programs in which many volunteers donate time to make care free to patients, our dental program relies primarily on paid staff. This, coupled with high material and lab expenses, results in the need for some costs to flow to patients. With its latest grant to fund the purchase of an intraoral scanner, the Foundation will help lower patient costs for items like crowns, partials, and dentures. The scanner will cut the number and duration of patient appointments in half; eliminate unpleasant procedures such as mold impressions; expedite and

reduce the cost (but not quality) of lab work; and open the door for new partnerships with labs using cutting edge technologies – such as 3-D printing – that drive down costs. This will have a direct, positive impact on the health and quality of life of so many AFC patients for whom crowns, partials, and dentures are often out of reach, even with our drastically reduced fees.

Today, addressing SDOH needs and advocating for improvements in the conditions that shape our community’s health landscape are integral facets of AFC’s daily mission.

Under Pat’s astute, imaginative, and strategic stewardship of NVHF, our neighbors enduring low incomes and lacking health insurance have found a tireless champion dedicated to fortifying the local health safety-net. As we bid farewell to this remarkable leader, we celebrate Pat for a legacy that has led to a healthier and more equitable community for all.
